Sir,

Sub: Filling up the post of Deputy Chief Mechanical Engineer (Electrical / Electronics & Communication) in Cochin Port Trust, by absorption through Composite Method.

Ref: This office letter No. A4/Dy.CME/Circular/2019-S dated 01.04.2019.

In continuation of this office letter cited above, applications are once again invited for filling up one post of Dy. Chief Mechanical Engineer(Ele./E&C) in the Scale of Pay of Rs.80000-220000 (Pre-revised Rs.16000-20800) in Cochin Port Trust by absorption through composite method.

2. As per Recruitment Rules, for absorption through composite method, Officers holding analogous posts or the posts of Superintending Engineer and equivalent posts in the Electrical /Electronics & Communication discipline of M&E Engg.Deptt. in the Scale of pay of Rs.13000-18250 (Revised Rs. 60000 -180000) with three year regular service in the grade in the Electrical /Electronics & Communication discipline in a Major Port Trust or Superintending Engineer and equivalent post in the Electrical /Electronics & Communication discipline of M&E Engg.Deptt. with two years regular service in the grade and a combined regular service of seven years in the Scales of Pay of Rs.10750-16750 (Revised Rs.50000 - 160000) and Rs.13000-18250 (Revised Rs. 60000 -180000) in the Electrical /Electronics & Communication discipline in a Major Port Trust will be eligible. Recruitment Rules is attached as **Annexure-I.**

3. The requisite educational & other qualifications prescribed as per R.R., are as under:-

- (i) Degree or equivalent in Electrical /Electronics/Electronics &Communication Engineering from a recognized University/Institution.
- (ii) The selection is by merit for which the benchmark in overall grading in the ACRs/APARs will not be below "Very Good".

4. Applications in the prescribed format (**Annexure-II**) from eligible and willing Officers, who satisfy the provisions of recruitment rules for the post of Dy.Chief Mechanical Engineer (Ele./E&C), may be forwarded along with the following documents so as to reach this office **on or before 19-06-2020, which shall be the crucial date for determining the qualification and experience.**

- a) Attested copies of Educational & Professional qualifications.
- b) Attested copies of ACRs/APARs of the applicant for the last 5 years .
- c) No-Objection Certificate of the respective Ports.
- d) Two recent passport size colour photographs in a sealed envelope.
- e) An undertaking of the applicant not to withdraw his candidature, if selected.
- f) Certificate by Head of Office of the Applicant as per the format.
- g) Vigilance/Administrative clearance of the concerned Port in the Proforma prescribed by the Ministry (**Annexure-III**).

5. The Veracity of the University Certificates produced by the applicants and the recognition of the degree obtained by the applicant may be ensured and certified.

6. The applications received through proper channel only will be entertained. The applications received after the last date or without ACRs/APARs and other requisite documents or otherwise incomplete will not be considered.

7. The applicants who have already applied earlier in response to the vacancy circular No. A4/Dy.CME/Circular/2019-S dated 01.04.2019 cited under reference, need not apply again. However, Vigilance Clearance in respect of such applicants need to be furnished afresh.
