  6. The veracity of the University Certificates and the recognition of the Degree obtained by the applicant may be ensured and certified.
3. The applicants should have at least 3 years service left as on 01.01.2021 for retirement on superannuation in the parent organization.
4. The applications received through proper channel only will be considered. The applications received after the last date or without ACRs or otherwise incomplete will not be considered.
