Sub: Filling up one post of Deputy Chief Engineer (Civil) in Cochin Port Authority,  
by absorption through Composite Method.

1. Applications are invited for filling up one post of Dy. Chief Engineer (Civil) in the Scale of Pay of Rs.80000-220000 (Pre-revised Rs.16000-20800) in Cochin Port Authority which will fall vacant w.e.f.01.03.2026, by absorption through composite method.
2. As per Recruitment Rules, for absorption through composite method, Officers holding analogous posts or post of Superintending Engineer and equivalent posts in the respective discipline of Civil Engg. Dept. in the scale of pay of Rs. 60000-180000 (pre-revised Rs. 13000-18250) with 3 years regular service in the grade in a Major Port or Superintending Engineer and equivalent posts in the respective discipline of Civil Engg. Deptt. with 2 years regular service in the grade and a combined regular service of 7 years in the scales of pay of Rs. 50000 - 160000 (Pre-revised Rs. 10750-16750) and Rs. 60000-180000 (pre-revised Rs. 13000-18250) in the respective discipline of Civil Engg. Deptt. in a Major Port will be eligible. The selection is by merit for which the benchmark in overall grading in the ACRs will not be below "very good". The requisite Educational qualification prescribed as per RR are: "Degree or equivalent in Civil Engg. from a recognised University/Institution. Recruitment Rules attached as **Annexure -I**.
3. The crucial date for determining the qualification and experience shall be 01.03.2026. Applications in the prescribed format (**Annexure-II**) from eligible and willing Officers, who satisfy the provisions of recruitment rules for the post of Dy.Chief Engineer (Civil), may be forwarded with prior approval of the Competent Authority and with the following documents, so as to reach this office **on or before 17.11.2025**.
  - a. Attested copies of Educational & Professional qualifications.
  - b. Attested copies of ACRs/APARs of the applicant for the last 5 years .
  - c. No-Objection Certificate of the respective Ports.
  - d. Two recent passport size colour photographs in a sealed envelope.
  - e. An undertaking of the applicant not to withdraw his/her candidature, if selected(**Annexure-III**).
  - f. Certificate by Head of Office of the Applicant as per the format(**Annexure-IV**) .
  - g. Vigilance/Administrative clearance of the concerned Port in the Proforma prescribed by the Ministry (**Annexure-V**).



4. The veracity of the University Certificates produced by the applicants and the recognition of the degree obtained by the applicants must be ensured and certified.
5. The candidate who withdraws his candidature for the post after his selection by the Services Selection Committee, will be liable for debarment from future selection to Dy. HoD level posts in all Major Port Authorities for a period of two years, as per the instructions issued by the MoPS&W, vide letter No. A-29018/4/2018-PE-I dated 11.08.2021.
6. The applications received through proper channel only will be entertained. The applications received after the last date or without ACRs/APARs and other requisite documents or otherwise incomplete will not be considered. In case of receipt of advance copy of application in respect of any applicant by this Port, candidature of the applicant will not be considered, if his/her application is not received through proper channel within 15 days of the last date of receipt of applications.
