REQUEST FOR QUOTATION

Bids are invited through Government e- Marketing Place (GeM Portal) in Single Stage Two Cover bidding procedure [Technical Bid and Financial Bid] to provide one Ultra Sound Scanning machine at Cochin Port Authority Hospital, Willingdon Island, Cochin, Kerala State as per the specifications and conditions given below.

Specifications of Ultra Sound Scanning Machine required:

3 Probes (Convex probe-1 No., Linear probe-1 No., TV probe-1 No.) on **Monthly Rental basis for 1 year from the date of award of contract.**

Terms and Conditions:

1. The bidder should have satisfactorily completed the similar type of rental for scanning machine for any of Central Public Sector Undertaking (CPSU) / Central Government Institution / any Port Hospital / Govt. Hospital/ Private Hospital at least for one year during the last 3 years ending on 30.09.2025. Copy of order and satisfactory performance certificate issued by the Client shall be submitted along with the quotation.
2. The scope of the contract comprise of maintenance i.e., repairs, replacement of spare parts and accessories etc. of the above equipment for the period specified in the contract.
3. The rate quoted will be valid for the entire contract period of 1 year from award of contract. The rate quoted should be firm and should not be linked up with any price variations clause. No other charges apart from the quoted rate will be paid.
4. **The rate should be quoted for 12 months (1 year) and should be inclusive of applicable GST.**
5. The contract will be placed for the L1 quote.
6. 24x7 Service shall be available throughout the contract period for the breakdown/service calls as and when required. The repair/service shall be attended immediately on intimation of defect to the contractor.
7. Delay beyond 48 hours from the time of intimation of defect will attract LD.
8. If any other incidental electronic failure, the contractor will repair or replace the machine by same model or other one within 48 hours.
9. If the Machine is down for more than 5 days, a standby Machine shall be provided.
10. Any failure on the part of the firm to attend the defect beyond 48 hours from the time of intimation shall be deemed to be a breach of the terms and conditions and will attract LD @ 0.5% per week or part thereof of the monthly rent subject to a maximum of 10% of the monthly rent.

11. Quality Control: The firm who undertakes the rental contract will not be allowed to sublet the contract to any other agencies, once the contract is accepted the sole responsibility will be with the contractor.
12. In respect of all labourers directly or indirectly employed in the works for the performance of the contractor's part of agreement, the contractor shall ensure the protection of PF / Medical facilities / Insurance of the workers employed by him at contractors own account, as per Govt. orders.
13. Cochin Port Authority shall have the option to terminate the contract if the service rendered is found to be unsatisfactory and in such cases only pro-rata contract amount shall be paid. The Competent Courts at Cochin will have the jurisdiction to deal with any legal matters or dispute arising out of this contract.
14. Local registered office should be available in Cochin.
15. An agreement on Kerala stamp paper worth Rs.200/- to be executed by the successful bidder as per the format attached.
16. Payment Conditions: Payment will be made on monthly basis against submission of invoice duly certified by the person in charge. The payment is only through e- payment.
17. The bidder should upload signed and sealed RFQ as a token of acceptance of specifications and conditions of this bid.
